Course title:	Public Policy in the Western Europe

Course description:	The course is designed for students interested in studying public policy in Western Europe and understanding of the complexity of policy problems in which the different branches of economics and social science have equal roles. This course is about preparing, designing and selecting public policy (public strategies, programs and projects). This course helps students understand the dynamics of the political environment, and develop strategies to engage with it. Students will learn how to be effective participants in public policymaking, as policy analysts, administrators, and advocates, by gaining tools to help them assess a political environment, recognize the unique challenges that it imposes, and explore what motivates and constrains the various actors in it. Students will learn these skills in comparative perspective, with exposure to a variety of domestic policymaking environments in Europe.

Course objectives:

The course is intended to train students:

- To evaluate the factors of a political environment related to policy advocacy;
- To forestall the challenges that may take place in the
- policymaking process in different domestic political environments:
- To recognize the competing interests and strategic alternatives that surround any issue, particularly in different domestic policy environments, and why this recognition is a necessary complement to issue analysis;
- To improve their written and oral communication skills:
- To work in teams;
- To understand the policymaking environments of countries in Europe.

Admission requirements:

Students are likely to meet the following requirements to apply for the course:

- at least level B2 of English proficiency or equivalent;
- a relevant field of study/major/professional qualification (Bachelor's degree in Social Science or equivalent);
- willingness to work in an international team on real cases. Applicants are also expected to have completed the following courses (desired but not necessary): Management Theory, Organizational

Management, Strategic Management, Change Management, Managerial Psychology.

The course combines interactive lecturing, training workshops, class discussions, as well as project and case study group work and simulations to achieve the learning outcomes.

Learning activities and teaching methods:

The assessment is based on the active participation in the course discussions, trainings and simulations, as well as in presenting and reporting on the projects' results. Course attendance is required for a student to be graded. When absent, students have to contact the Course Leader for additional course assignments.
